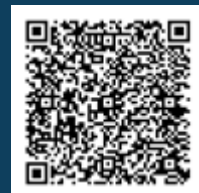

Become a CPA

STEP 1

Education Requirements

- ▶ **Get a Degree!** You must complete a bachelor's degree or higher from an accredited institution and obtain a total of 150 semester hours. **You can take the CPA Exam before you have met the 150 hour requirement for the CPA license. See page 11 for Exam eligibility requirements.*
- ▶ **Complete at least 30 semester or 45 quarter hours of accounting, including at least 24 semester or 36 quarter hours at the upper division level.** A maximum of six semester or eight quarter hours from internship programs may be included.
- ▶ **Complete at least 24 semester or 36 quarter hours in general business such as:**
 - ☑ algebra, calculus, statistics, probability
 - ☑ business communication
 - ☑ business law
 - ☑ economics
 - ☑ ethics
 - ☑ finance
 - ☑ management
 - ☑ technology/information systems
 - ☑ marketing

STEP 2

Apply, Study and Pass the CPA Exam

- ▶ **Apply**
 - ☑ Review the CPA Candidate Guide provided by NASBA before submitting any applications
 - ☑ Apply with the National Association of State Boards of Accountancy (NASBA) to determine if you're eligible to take the Exam
 - ☑ Submit required fees and materials with application
 - ☑ If you are eligible, you'll receive a Notice To Schedule
 - ☑ Schedule your Exam through Prometric
 - ☑ You have 30 months to complete all four sections after the release of your first Exam score
- ▶ **Study**
 - ☑ Expect to spend 120 hours studying for each Exam section
 - ☑ Use a CPA Exam review course
 - ☑ Attend a virtual Mock CPA Exam
 - ☑ Review AICPA's CPA Exam Blueprints, which detail knowledge and skills needed to prepare for the Exam

STEP 3

Meet the Experience Requirements and Take the Ethics Exam

- ▶ Experience may consist of providing any type of services or advice using accounting, attest, management advisory, financial advisory, tax or consulting skills.
- ▶ Acceptable experience shall include employment in industry, government, academia or public practice.
- ▶ No fewer than 2,000 hours of experience (earned in no less than one year or more than three years). Experience must be earned within the 10 years immediately preceding the application for certification.
- ▶ Pass an Ethics examination given by the American Institute of Certified Public Accountants (AICPA) with a score of 90% or better.

STEP 4

Apply With the Tennessee State Board of Accountancy

- ▶ The Tennessee State Board of Accountancy is notified when a candidate has met the education requirements and passed the CPA Exam. NASBA transmits to the Board your candidate file containing CPA Exam grades and education transcripts.
- ▶ After meeting all requirements and having confirmed the Board's receipt of your candidate file, you may apply for a Tennessee CPA license.
- ▶ The initial CPA license application fee is \$100.

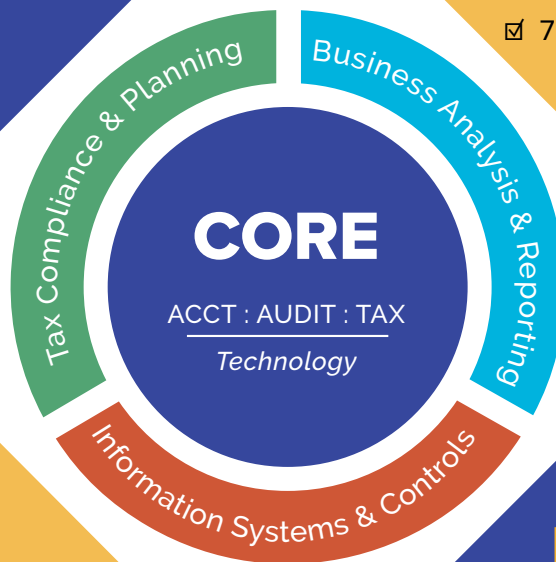

Requirements To Sit for the CPA Exam in Tennessee

► EDUCATION

In order to sit for the Exam, you must meet the following education requirements:

- Completed a four-year bachelor's degree or higher from an accredited institution
- Completed at least 18 semester or 27 quarter hours of accounting at the upper division, excluding credits from internship programs

Upper division courses are from the junior, senior and graduate levels.

► COMPLETION DEADLINE

Education

You may submit your application for the Exam while your education is still in progress; however, you must complete your education before you sit for any section of the Exam. No credit for the Exam will be given to you if you fail to successfully complete your education prior to sitting for the Exam.

► RESIDENCY

There is not a residency requirement for the state of Tennessee.

How is the Exam scored?

- ☑ To become a certified public accountant, you must pass all three core sections and one discipline section of the Uniform CPA Examination. Each of the four parts of the examination is graded on a scale of 0 to 99, using a rigorous scoring structure. The minimum passing score is 75.
